# Memberships

**MEMBERS are reminded that SHCV Financial Year commences 1st July 2017.**

Aon has again been retained as our Insurance Broker for the upcoming year, an important aspect is: **Personal Liability Insurance – Active Members**

*\*This policy covers you in respect of Personal Liability twenty-four (24) hours a day, seven (7) days a week whilst involved in recreational non income - earning equestrian activities*

*\*It covers you should you be held liable for causing bodily injury or property damage to a third party, including whilst attending or participating in Show Horse sanctioned and/or authorised Show Horse activities involving Show Horse disciplines.”*

In addition for **Active Members the 24/7 PA** element of the SHC Policy is for recreational purposes & identifies cover for: *“Riding Members : – At all times 24 hours a day, 7 days a week whilst involved in non-income earning equestrian activities including:*

- o Participating in rides, displays, exhibitions, performances organised by SHCA*
- o Participating in training or practice sessions or official functions arranged by SHCA*
- o Engaged in organised social or administrative activities arranged by the SHCA*
- o Temporary overseas visits*

As a non for profit recreational organisation, the Council Membership enjoys many benefits including: all levels of competition, training, opportunities for Juniors & National presence & structure that allows a voice at club & Council levels.

Should an Active (Adult) Member be engaged in Income - earning equestrian activities then additional products are available from Aon that protect them against injury (P/A) &/or Income Protection. If providing tuition then Professional Indemnity Insurance is also available, the risk in being uninsured is great.

Risk management & the well-being & protection of our members & their horses is of our utmost priority. The past year has seen a reduction in claims, that is a great result but all need to continue to be vigilant in this regard.

**PLEASE NOTE** : *As the SHCV are currently upgrading our Membership Card system there will be a delay in getting your new cards out to you. In the meantime once your payment has been processed your details will be updated and you will be able accessthe SHC Database to process entries etc.*

### RESIDENCY & OTHER RULES APPLYING TO STATE EVENTS

There appears to be some confusion on State Event rules due to not all being covered under SHC Competition Rules, reason is rules for State events can vary from State to State.

A State Title is looked upon as a prestige Event & should be treated as such. All rules are to be read in conjunction with other rules of the Show. If in doubt please direct your enquiry to SHC Secretary 02 4311 2854 or romastone11@gmail.com

Some specific Rules are required to apply to all State Events including but not limited to:

**OWNERSHIP** - All horses shall be currently registered with the Show Horse Council of Australasia Inc. NATIONAL SADDLE HORSE REGISTER and shall be a resident of & be owned by a resident of that State for a period of not less than three (3) calendar months prior to closing date of Entries.

**CURRENT RESIDENCY RULE** is—\*Members residing within 100km of the border would be able to remain a member of the current affiliate club and with provision of a Stat. Dec. be able to compete at the adjoining state's "Horse Of The Year Show" . Proof of distance to be provided annually. The States will need to monitor those HOTY Entries that are acceptable under this Rule to ensure compliance. Note: Entries not meeting the criteria will be considered ineligible.

#### **OTHER STATES**

1. If any Horse has competed in another State's Horse Of The Year Show held in a calendar year, it is ineligible to compete in EITHER the OPEN HORSE section or the OPEN SHOW HUNTER Section in that States Horse of The Year Show.
2. If a Rider has competed in another State's Horse Of The Year Show held in a calendar year, he/she is ineligible to compete in the RIDER Section of the States Horse Of The Year Show.

Members are well catered for with many other GN Qualifiers for which these particular rules are not applicable.



Our members asked so we have delivered. You suggested that we have Grand National qualifying Rider classes at the SHCV Junior Equestrian Showcase and we have delivered. So this year the Rider 6yrs & under 9yrs, 9yrs & under 12yrs, 12yrs & under 15yrs & 15yrs & under 17yrs will be GN Qualifiers at Tatura in October.

However to enable this so happen we have had to make a sacrifice. The above classes will be removed from the SHCV Southern Stars schedule. This is the only way we could work this as we are unable at this stage to add any new qualifying classes.
